## ACNM Certification Council, Inc. 2003 Annual Report

The ACNM Certification Council (ACC) was incorporated in October 1990 as a 501 (c) (6) professional association. The mission of ACC is to protect and serve the public by providing the certification standard for individuals educated in the profession of midwifery. ACC fulfills its mission through three primary activities: a national examination for initial certification as a nurse-midwife (CNM) or midwife (CM), a recertification program for CNMs or CMs, and professional discipline.

During 2003, the national certification examination was administered in multiple sites throughout the country, on January 17, June 27, and October 17. A special examination administration was also held on February 28, 2004 because severe winter weather necessitated the cancellation of one examination site for the scheduled January administration. A total of 331 new CNMs and 5 new CMs achieved initial certification. For first-time candidates, the overall pass rate on the certification examination was 86%. ACC's e-commerce website was developed in 2003 and allows examination applicants to apply on-line and pay their examination fee by credit card.

The Certificate Maintenance Program (CMP) Committee achieved its goal of having all three CMP domain modules available each year. Each module is now available for 3 years. The new release module for 2003 was Intrapartum, Postpartum and Newborn Care. Other improvements to CMP accomplished in 2003 include on-line submission of annual activity reports and the ability to order CMP materials on-line through ACC's new ecommerce website. In 2004, individuals initially certified in 1996 must complete all requirements for re-certification.

A Computer-Based Testing (CBT) Task Force was appointed to develop a plan for the implementation of computer-based testing by 2005. The Task Force is led by the chairperson of the Examination Committee and composed of the chairperson of the Credentials, Administration & Reporting Committee, a representative from the Directors of Midwifery Education (DOME), a student midwife, ACC's Executive Director, ACC's Exam Consultant, and a CBT consultant. A request for proposals from potential CBT vendors will be issued in the first quarter of 2004.
