# AMERICAN MIDWIFERY CERTIFICATION BOARD 2018 Annual Report



## Background


The mission of the American Midwifery Certification Board (AMCB) is to protect and serve the public by leading the certification standards in midwifery. The AMCB fulfills this mission through three primary activities: developing and administering a validated certification exam to assess the entry-level competencies of nurse-midwives (CNM) and midwives (CM); requiring a mandatory certificate maintenance and re-certification program for all AMCB certified CNM/CMs, and maintaining professional discipline.

Since 2002, the AMCB has been accredited through The National Commission for Certifying Agencies (NCCA). Compliance with the NCCA Standards for the Accreditation of Certification Programs mandates that NCCA accredited organizations adhere to modern standards of practice in the certification industry. Both the Certified Nurse-Midwife (CNM) and Certified Midwife (CM) certification programs are accredited by NCCA through 12/31/2021.

## **Recertification/Retirement**

Since the move to time-limited certificates, a small portion of the certificant pool continues to retire. AMCB continues to anticipate that the recertification pool will grow as the number of new certificants increases. As noted in Table 1 and Figure 1, the number of retired midwives over the last 3 years has remained relatively stable: 2.3% in 2016, 2.3% in 2017, with a slight increase of 0.1% (2.4%) in 2018.



## **New Certification**

The national certification exam (NCE) has been administered via computer-based testing (CBT) since 2005. AMCB's testing partner; PSI Services, offers testing 52 weeks of the year, 5 days each week and at least one Saturday per month in all 50 states within the U.S. Candidates for certification are able to take the examination at their convenience at any of PSI's 300 plus testing sites as soon as their application is approved. Candidates receive official pass/fail results at the conclusion of their examination. AMCB then issues a formal certificate as well as wallet-sized certification card for ease in documenting current certification.

There was a small decrease (-5.1%) in the number of newly certified CNM/CMs in 2018. This is the first decrease since 2014 (See Table 2 and Figure 2). Additional details by state can be found at: <u>http://www.amcbmidwife.org/about-amcb/annual-reports</u>.

# **Pass/Fail Rates**

Traditionally, from 2000-2014, AMCB had not reported on the total number of candidates who have taken the exam, or pass/fail statistics, however, as of 2015, changes in reporting requirements by NCCA require that this information be included. Table 3 presents this information. Note that the Total Candidates Examined includes initial and repeat exam attempts in one combined number and pass/fail rate percentages.

In 2018 there was a pass rate of 80.8%, this was decreased from the three previous years (91.8% in 2015, 93.9% in 2016, 90.5% in 2017). Following the results of the 2017 Task Analysis, the AMCB Certification Exam was updated to reflect changes in the typical tasks performed by beginning level CNM/CMs practicing less than 5 years. This can often result in changes in pass rates as reflected in 2018.
